

# **Beaverton Branch Grand Opening Sweepstakes Rules**

## 1. Sweepstakes Administration

This sweepstakes is being administered and operated by Unitus Community Credit Union (Unitus).

#### 2. How to enter

No purchase is necessary to enter. Receive one entry ticket at the Beaverton branch of Unitus at the Grand Opening event and be automatically eligible for the sweepstakes drawing for one of eleven prizes: Mystery Gift Card (8), iPhone 15 (1), Nintendo Switch (1), or \$1,000 Beaverton Bucks\* (1). To enter without earning an automatic entry, email your name, address, and phone number to <a href="marketing@unitusccu.com">marketing@unitusccu.com</a> no later than 5:00 p.m. on March 1, 2024 – email entries will be placed in the Mystery gift card drawing for one of the \$25 gift cards only. Odds of winning depend on the number of entries received.

Receive one (1) entry for attending the Grand Opening event and one (1) entry for being a Unitus member. Up to one (2) entries are allowed per person. Entries are placed in the prize bucket as selected by the person entering the drawing(s).

### 3. Sweepstakes Period

The Sweepstakes period runs between 4:00 p.m. and 6:00 p.m. on March 1, 2024, unless entered via email (see above). The winners will be drawn at the Beaverton Branch Grand Opening event between 5:15 p.m. and 6:00 p.m. on March 1<sup>st</sup> and all winners must be present to win unless entering via email.

### 4. Eligibility

To be eligible for the Sweepstakes you must be a natural born person, lawful permanent resident of the United States, 14 years of age or older and reside in our field of membership. To be eligible for the \$1,000 Beaverton Bucks you must be a natural born person, lawful permanent resident of the United States, 18 years of age or older and reside in our field of membership. Limit of one entry per person. Void where prohibited by law. Employees of Unitus Community Credit Union and members of their immediate family are not eligible to win. Members of the immediate family; including, grandparents, parents, spouse, children, stepchildren, grandchildren, brothers, sisters, half-brothers, half-sisters, aunts, uncles, and domestic partners of any person who qualifies or qualified for membership and of deceased members who qualified for Unitus membership at the time of death.

#### 5. Prizes

Unitus will select eleven (11) prize winners. The prize winners will be randomly selected from all eligible entries in each drawing. One drawing for each of the eleven (11) prizes that may be awarded to the eligible winners are Mystery gift card (8), iPhone 15 (1), Nintendo Switch (1), or \$1,000 bucks\* (1).

The prizes awarded to the eligible winners are not transferable or exchangeable for any other prize. If a winner cannot be contacted or is disqualified for any reason, Unitus reserves the right to determine an alternate winner or not to award that winner's prize, in its sole discretion.

The odds of being the prize winner depend on the total number of eligible entries received. If any selected winning entry is disqualified for any reason allowed under these rules, Unitus will select another winner. All decisions are final and binding. Unitus shall not be responsible for late, lost, misdirected, or unsuccessful efforts to notify winners.

\*The winner of \$1,000 may opt to receive cash, have the money deposited into their Unitus account, or request a Visa® gift card.

### 6. General Conditions

Federal, state, and local tax liability and any other expenses are the sole responsibility of prizewinners. Void where restricted and prohibited.

Any valuation of the prize stated above is based on available information provided to Unitus, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Winner is solely responsible for reporting and paying all applicable taxes related to the prize. Winner must provide a valid taxpayer identification number or social security number before any prize will be awarded. Any person winning over \$600 in prizes from Unitus will receive an IRS form 1099 at the end of the calendar year and a copy of such form will be filed with the IRS. The iPhone 15 is valued at \$829 and the Nintendo Switch is valued at \$325 (other prizes are (2) \$25; (2) \$50; (2) \$75; (2) \$100 mystery gift cards and \$1,000 cash).

### 7. Consent to Publicity and Release

By accepting the prize, winner consents to the use of his/her name and likeness for publicity purposes without further compensation, unless prohibited by law. All entrants agree to release and hold harmless Unitus and their immediate family from all claims of any kind arising directly or indirectly from the Sweepstakes, from any Sweepstakes prize, or from any publicity about the Sweepstakes.

#### 8. Miscellaneous

By entering the Sweepstakes, you agree to comply with all terms and conditions mentioned herein. Noncompliance with any entry procedure will result in disqualification.
